First Lecture: "The Dialectics of Coloniality/Modernity: Rewriting a Classic"

Abstract: This paper sets out from two premises: first, that Adorno and Horkheimer's Dialectics of Enlightenment is a classic of both philosophy in general, and critical theory in particular; second, that the book merits rethinking/rewriting, not only because it was written at the darkest hours of the Twentieth Century, but also because some of its key themes have not aged well. In this paper, I propose how I would rewrite this classic, and I would do so with this table of contents: first, instead of beginning with Homer, I would begin with the Gilgamesh, an even more ancient text than Homer's Odyssey. This ancient text is amazingly contemporary, as it raise questions about ecology, sexuality, mortality, and friendship. Then, I would turn to the Odyssey, but would instead focus on three themes: misrecognition, conjugal love, and Penelope's cunning, which is the other background of the story of the quest to return home (Heimkehr). Then, I would turn to Augustine and Boethius to profile what I will call theophagy, the eating of God, which births the soul/conscience, i.e. an internal panopticon. The next chapter in my re-writing of the classic would be on "the divinification of the human: Picco de la Mirandola and Juan Luis Vives," which mark a major pivot in the constitution of the modern subject. This aspirational ToC then would turn to the debate between Juan Gínes de Sepulveda and Bartolomé de las Casas on the humanity and rights of Amerindians. Another chapter would be devoted to "The Invention of the White/Aryan Race and Herrenvolk Ethics of Extermination." This "fragment" would include notes towards a deconstruction of the "Anthropocenic Anthropological Machine." This paper contributes to the theme of "Decolonial Critical Theory."

Second Lecture: "Poverty and Latin American Philosophy"

In this chapter I focus on the "development of underdevelopment," "the theology of liberation," and "the philosophy of liberation," because combined they provided the most sustained and in-depth analysis, study, and critique of the problem of poverty with a distinct focus. In addition, given the number of figures that contributed to these current, we will focus on a handful of thinkers who have most consistently and originally contributed to the philosophical discussion of "poverty" not only in Latin America but also in our contemporary world. By studying at least these three movements of liberation within Latin American we will understand how collectively they contributed to at least five ways of making sense of poverty: anthropologically, culturally, ecclesiologically, eschatologically, and soteriologically.
